An Act to apply a sum from the Consolidated Fund for the service of the year 2016 and to appropriate that sum for the service of that year.

**ENACTED** by the Parliament of Malaysia as follows:

**Short title**

1. This Act may be cited as the Supply Act 2016.

**Issue and appropriation for the service of the year 2016**

2. The issue of a sum not exceeding one hundred and sixty-three billion four hundred and forty-seven million seven hundred and fifty-six thousand ringgit (RM163,447,756,000) from the Consolidated Fund for the service of the year 2016 is hereby authorised and that sum is appropriated for the purposes specified in the Schedule.
