An Act to apply a sum from the Consolidated Fund for the service of the year 2022 and to appropriate that sum for the service of that year.

ENACTED by the Parliament of Malaysia as follows:

Short title

1. This Act may be cited as the Supply Act 2022.

Issue and appropriation for the service of the year 2022

2. The issue of a sum not exceeding one hundred and fifty-six billion four hundred and twelve million eight hundred and fifty-eight thousand eight hundred ringgit (RM156,412,858,800) from the Consolidated Fund for the service of the year 2022 is hereby authorized and that sum is appropriated for the purposes specified in the Schedule.
