A BILL

An Act to apply a sum from the Consolidated Fund for the service of the year 2023 and to appropriate that sum for the service of that year.

ENACTED by the Parliament of Malaysia as follows:

Short title

1. This Act may be cited as the Supply Act 2023.

Issue and appropriation for the service of the year 2023

2. The issue of a sum not exceeding one hundred and ninety billion nine hundred and forty-seven million three hundred and fifty-three thousand three hundred ringgit (RM190,947,353,300) from the Consolidated Fund for the service of the year 2023 is hereby authorized and that sum is appropriated for the purposes specified in the Schedule.
